Holly's Summer Recipe

I happily just served a fresh dill potato salad at home in Chester County. It makes for the perfect side dish to any summer meal. Enjoy!

Dill Potato Salad

KEY INGREDIENTS FOR DISH:

- RED POTATOES
- HARD BOILED EGGS
- ORGANIC BUTTER
- DILL PICKLES
- GREEN ONIONS
- FRESH DILL
- LEMON
- SALT

DIRECTIONS:

- Dice five or six red potatoes into semi-small cubed chunks. Skin optional.
- Boil the potatoes for seven minutes.
- In small sauce pan, bring olive oil to simmer and add lemon, the fresh 2 cups of fresh dill.
- Let simmer for five minutes with a bar of organic butter.
- Poor the sauce onto the cooked potatoes in a large bowl.
- Add fresh green onions and dill pickles, both ingredients should be very well diced.
- Stir. Then add four hard boiled organic eggs into the bowl after dicing them into semi-small pieces.
- Add salt.
- Serve.
